# Did not say I will overthrow govt like Arab Spring: Wangchuk to SC

**PTI NEW DELHI**  
Climate activist Sonam Wangchuk, who is under detention in Jodhpur Central Jail, denied in the Supreme Court on Thursday allegations that he made a statement to overthrow the government like Arab Spring, emphasizing that he has the democratic right to criticise and protest.

Senior advocate Kapil Sibal, appearing for Wangchuk's wife Gitanjali Angmo, submitted before a bench of Justices Arvind Kumar and P B Varale that police have relied on a selective video to mislead the detaining authority.

"Look at the video. What he says (according to the police) is if the government of India will not give statehood, he will overthrow the government like the Arab Spring.

"He does not say so. I will give the transcription of the video," Sibal told the bench.

The Arab Spring is a series of anti-government protests, uprisings and armed rebellions that spread across the Middle East and North Africa around 2010 and 2018.
